Sno-Isle Libraries board vacancy

Connector street to Terrace Avenue planned for later this decade

SNOHOMISH — The city plans to build a connector street from 22nd Street to Terrace Avenue later this decade, in part to ease congestion relating to the future Walsh Hills subdivision in the enclave of northeast Snohomish. Terrace currently is a dead-end street with just 16th Street as its route.

Design work could be done in 2023 and construction may start in 2026 in the city's plans.

Walsh Hills is a subdivision of 111 homes being built on the former site of the Snohomish Delta Rehabilitation Center (known locally as the Snohomish Chalet) run by the Walsh family. It closed when finances tightened up to be able to run the center for brain-injured adults.

The preliminary cost estimate to build the connector road is approximately \$1.9 million, the city said.

Walsh Hills' builder, D.R. Horton, should accumulate \$123,431 in traffic impact fees to the city's general road fund for the subdivision, retired city planning director Glen Pickus said in 2021.

The \$123,431 estimate is because "the current Traffic Impact Mitigation Fee is \$1,603 per P.M. Peak Hour Trip. One singlefamily house generates one P.M. Peak Hour Trip. However, they get credit for the number of P.M. Peak Hour Trips that the previous development generated, which was 34. Therefore, they must pay 77 multiplied by \$1,603," Pickus wrote..

SNOHOMISH — In its first year of distribution, Empyrical Orchard in Snohomish was named Micro Producer of the Year of 5,000 gallons or less at The Great Lakes International Cider and Perry Competition in mid-May.
